AGREEMENT ON COOPERATION

ARTICLE I

This Agreement on Cooperation (hereinafter the Agreement) defines the purpose and method of cooperation between the contractual parties, IUS and AGENT

ARTICLEII

The purpose of this Agreement is to establish sales representation of the IUS study programs in Turkey for soliciting potential students to enroll into IUS, and specifying details for implementation of this agreement.

IUS retains the right to appoint other representative in Turkey at its sole discretion.

ARTICLE III

Obligations of the contractual parties

Agent is obliged to act for and on behalf of IUS in the following matters:

- To mediate towards enrolling potential students into undergraduate, master and PhD studies at the International University of Sarajevo;
- To mediate towards enrolling potential students into English Language School programs, including the Summer Schools and Summer Programs;
- 3. To mediate towards enrolling potential students into Summer Schools and Summer Programs of the University;
- 4. To facilitate the process of making study contracts with prospective students, and
- 5. To make an assessment of the profile of potential students before bringing them to IUS.

ARTICLE IV

Potential candidates have equal right to apply on enrollment announcement under equal conditions as citizens of Bosnia and Herzegovina, pending the validation of their academic degree qualification through equivalency process, in order to verify that they have adequate level of education to continue their education.

ARTICLE IX

Transitional and Final Provisions

IUS has the right to immediately terminate this agreement, if it is being misused, or there is a suspicion that it is being misused, or if Agent is not representing IUS in accordance to this agreement and best practices (e.g. study contracts are used for illegal transfer of people into Bosnia and Herzegovina or any form of violation of human rights, Agent is providing incorrect information to potential students or receiving additional payments for his work, etc).

ARTICLE X

The signatories of this agreement will resolve any disputes amicably in accordance with the principles of honesty and conscience, and if this is not possible, then the case will be transferred under the jurisdiction of the Municipal Court in Sarajevo.

ARTICLE XI

This agreement is signed in three copies both in English, two for the IUS and one for the Agent.

ARTICLE XII

Amendments to this agreement can only be made by signing the Annex to this agreement.

The Agreement is concluded for the period of one year, and it will become effective from the day it is signed.

Contracting parties can cancel this contract unilaterally or mutually at any time.

This Agreement consists of 12 articles and it has been signed by both parties.
